

PRIZE DRAW REGULATION

DENOMINATION

"WIN A 4-STAR STAY ON LAKE GARDA"

LENGTH

The initiative takes place from 3 June 2023 to March $31^{ST} 2024$ Final draw by April $30^{TH} 2024$.

TERRITORY

Italy.

DRAW AIM

The competition is held to advertise the services of the Promoter.

ADDRESSEES

Natural persons of legal age, having both of the following characteristics:

a) that we have subscribed to the "Blu Tribe Program";

b) who will stay during the initiative in a Blu Hotels facility in Italy.

Minors are excluded, therefore, from participation in the initiative, the legal persons and the employees/collaborators (and their relatives up to the second degree) of the Promoter Entity and its subsidiaries, as well as the employees/collaborators of the Blu Hotels facilities.

HOW TO TAKE PART

To take part to the competition, individuals (hereinafter "Customers" or, individually, "the Customer") must be enrolled in the "Blue Tribe Program" and stay in a Blu Hotels facility on Italian territory by March 31st 2022, this way you can access the final draw (more information under "PRIZES").

The customer to subscribe to the "Blu Tribe Program" must:

- link to the website www.bluhotels.it;
- enter the special section "Blu Hotels World", area "Blu Tribe" and register for free;
- insert a valid personal e-mail address and your personal data in the appropriate form (mandatory: e-mail, first name, last name, date of birth, address and city, telephone optional: information about the family);
- read and accept the data processing;
- -read and accept the conditions of membership of the "Blu Tribe Programme".

FINAL DRAW

PERSONAL DATA PROCESSING

Personal data, whether in paper or electronic format, will be kept for a period of time no longer than necessary to pursue the aforementioned purposes in accordance with the provisions of current legislation or to comply with precise legal obligations, unless otherwise provided.

The data of the participants will not be communicated to anyone or disseminated. Only the data of the winners and reservations will be recorded by the person in charge of the public faith of the competent CCIAA or the notary and used for the delivery of the prize to the person entitled.

Participation to the initiative is optional, but in the case of participation the provision of personal data by the participant is mandatory, to the extent necessary to allow the Promoter Entity to carry out the operations essential to the management of the Awards event, using the Delegated Entity and its possible suppliers.
